The objective of this evaluation is to determine whether EPA Region 4's Office of Environmental Justice followed policies and procedures when reviewing and selecting Environmental Justice Small Grants recipients for fiscal years 2010, 2011, and 2012. The anticipated benefits of this project include greater efficiency and effectiveness of EJ Small Grants selection processes.

We plan to conduct our fieldwork throughout EPA Region 4 and also Headquarters. The project will be conducted using generally acceptable government auditing standards. We encourage you to meet with us and provide any comments or concerns you may have in this area.
