Thank you for your May 10, 2018, memorandum that provided a supplemental written response to the subject Office of Inspector General (OIG) report.

The OIG issued this report to the U.S. Environmental Protection Agency (EPA) with two unresolved recommendations: Recommendation 1 to the Office of Water, and Recommendation 4 to the Office of the Chief Financial Officer. We consider the Office of Water's supplemental response adequate to resolve Recommendation 1. We accept the EPA's planned corrective actions.

We will close Recommendation 1 in the OIG tracking system as of the date of this memorandum. You should track implementation of Office of Water corrective actions in the agency's Management Audit Tracking System until all actions are completed.

With this memorandum, Recommendation 1 is resolved. A separate memorandum to the Office of the Chief Financial Officer resolved Recommendation 4. As a result, all recommendations in this report are resolved.
